Support for the West African Health Organization to strengthen Epidemiological Surveillance and Laboratory Systems

Call for International Bids (ICB) N° ICB/PROALAB-WAHO/2024/003

- 1. On the basis of a financing agreement between the German development bank KfW and ECO-WAS, represented by WAHO (West African Health Organization), the German government, through KfW, has allocated a budget to the project "Strengthening epidemiological services and health systems in ECOWAS countries". The aim of this program is to use part of the funds to support WAHO's efforts to improve epidemiological surveillance systems at national and regional level. Indeed, the overall objective is to better protect the population of the ECOWAS region against epidemic diseases, by strengthening laboratory operations in five countries (Ghana, Guinea Conakry, Guinea Bissau, Senegal and The Gambia).
- 2. The project supported by GFA Consulting Group, Hamburg, Federal Republic of Germany, in cooperation with Fondation Mérieux, Lyon, France, have signed a consortium agreement under this KFW-funded project to support 14 National and Regional Reference Laboratories in five countries in Ghana (x3), Guinea Conakry (3), Guinea Bissau (x1), Senegal (x5) & The Gambia (x2) and to procure program requirements financed from KfW revenues in accordance with the "Guidelines for Procurement of Consultancy, Works, Facilities, Goods and Non-Consultancy Services in Financial Cooperation with Partner Countries", section 2. 1.1. - 3. WAHO has applied for funding from KfW towards the cost of the project "Support to the West African Health Organization for the strengthening of epidemiological surveillance systems", and intends to allocate part of the proceeds to the payments foreseen in the contract(s) for supply and installation of laboratory equipment, Reagents & Consumables for National and Regional Reference Laboratories in five ECOWAS countries (Ghana, Guinea Conakry, Guinea Bissau, Senegal and The Gambia), in 4 Lots:

- 4. WAHO invites eligible bidders to submit bids for the supply and installation of laboratory equipment, reagents and consumables for fourteen national and regional reference laboratories listed above in Ghana, Guinea Conakry, Guinea Bissau, Senegal and The Gambia, on the basis of competitive bidding.
- 5. Tender will be by means of the International Qualified Tender procedure as specified in the KfW Procurement Guidelines ("KfW Guidelines") and the relevant WAHO regulations. The tender is open to ECOWAS and international companies that meet the eligibility criteria.
- 6. The tender includes the following lots
 - Lot 1. Laboratory Equipment for PCR and Immuno Assay
 - Lot 2. General Laboratory Equipment
 - Lot 3. Products and Materials for Laboratory
 - Lot 4. Reagents & Consumables
- 7. Bidders may bid for one of the above lots or for all eight lots. However, bidders must bid for all items in total quantity in any lot selected, a partial bid for a lot is not acceptable. For bids on all four lots, encrypted bids must be submitted separately for each lot.
- 8. 9. Les Tenders must be written in French and must be password protected. Tenders must be submitted electronically to https://data.wahooas.org/tenders/tenders/list no later than 1:00 pm UTC on September 18, 2024 at 1:00 pm UTC will de facto be rejected. Tenders submitted by any means other than those indicated above will not be accepted, opened or considered.



10. Bidders must check the Inbox and SPAM files for the automatic acknowledgement of receipt implemented by the bid submission platform set up at WAHO and ask any questions for clarification or assistance via the email address defined in point 8 above. For each lot, bidders are required to submit a bid guarantee and a line of credit issued by a bank or authorized financial institution (guaranter) in the amount of:

The opening date and the date for submitting passwords for opening the second envelope will be communicated to Bidders who are considered qualified after the first stage. The qualification documents and the technical and financial offers must be encrypted separately.

As the authority competent to accept the bid, the Purchaser reserves the right to accept or reject any or all bids without giving any reason. The award of the contract will be subject to the approval of the Purchaser and the No Objection Notice from KfW, Federal Republic of Germany.
